Public Input Format. The Commission discussed the logistics of the public input meeting scheduled for April 29. The meeting will begin at 6 p.m. The Commission will present the priorities and then take public comments. The public comment period will not be a Q&A session, it will be for the purpose of receiving comments.

Warren noted the charge of the Commission stated "At the conclusion of its prioritization of the options studied, and before making its final report to the Town Board of Commissioners, the Study Commission shall design and implement a process to educate and receive feedback from the Huntersville community and the key stakeholders identified by the Commission as to the Commission's prioritization of the five (5) options studied." It was suggested key stakeholders could include parents, teachers and school staff.

Notification to the public was discussed. Joseph Shook, Public Information Coordinator, suggested social media (Facebook and Twitter) and the Town's website could be used to notify public of the meeting. Shook also suggested Nextdoor. The Commission requested Shook go ahead and post the meeting.

It was suggested that the Commission ask the Town Board to amend their charge to just a presentation of the current facts, because if you are going to present the recommendation then why are you listening to anybody.

Rowell made a motion to request the Town Board revise Paragraph 8 of the Resolution creating the Huntersville Educational Options Study Commission to remove the language "conclusion of the prioritization" and have it just read "Before making its final report to the Town Board of Commissioners, the Study Commission shall design....."

Warren seconded motion.

Motion carried unanimously.

The Commission reviewed the calendar of upcoming meetings. April 29 will be public input, May 13 to review final presentation, May 20 presentation to the Town Board.

#### CLOSING COMMENTS
