Overview: The Town of Huntersville was awarded the NCDOT BikePed Planning Grant. As a result, the Comprehensive Bicycle Plan Steering Committee will be created in summer 2019 to serve for approximately 1 year as an advisory board to the Town of Huntersville Greenway, Trail, & Bikeway Commission and Board of Commissioners. The Steering Committee will consist of 11-15 members, representing a reasonable cross section of the Huntersville community (municipal limits and ETJ), and will be appointed by the Town Board.

Steering Committee members will be required to attend 4 meetings during the course of approximately 1 year (September 2019 – September 2020), will review the progress and content of the Community Plan Update, and will be asked to help encourage community participation during the entire project. You may attach any additional information you wish the Town to consider in evaluating your application. All applications and information provided, including attachments, are public records and are subject to being released upon request made pursuant to Chapter 132 of the North Carolina General Statutes.
